#### Waiting List Guidelines and Provisions

New preferred moorage agreements will only be granted to vessels with a **total overall length** for the following size categories:

60 + : No charge, 60 + slips do not yet exist.

\*The **overall length** of your vessel is figured by measuring the centerline from the furthest point to the furthest point; this includes the bowsprits, swim steps, dingys or any other protrusion.

- The cost of getting on each waiting list is \$50.00 including tax. To remain on the list, you need to pay the annual charge of \$50.00 no later than December 31, each year. Although the harbor will send a reminder, it is your responsibility to renew. If you fail to pay your fee in time, you will be removed from the list. **There are no exceptions to this rule.**
- Only one individual's name may appear on this application to be accepted as a preferential berth holder. Corporations, LLC's, companies and partnerships do not qualify. The wait list applicant must own or retain ownership of at least fifty-one percent (51%) of the boat to be moored or have a vessel lease for a minimum of one year.
- You do not need to own a vessel to be placed on a waiting list. If your name comes to the top of the list you have three options: (a) Accept the slip, if you do not have a vessel you have one year to obtain a vessel of the appropriate length. (b) Return to the bottom of the list. (c) Be removed from the list altogether.
- It is your responsibility to inform the harbor of any change in address. If your name comes to the top of the list and you do not respond within 30 days of the mailing notifying you of the stall, your name will be placed on the bottom of the waiting list.
- Provisions for this application are contained in Title twelve of Whittier Municipal Code 12.04.120B.
- Any decision may be appealed to the Port and Harbor Commission.
