## **ABSENTEE BY-MAIL VOTING INFORMATION**

### **HOW TO APPLY**

- Qualified voters of the City of Whittier may vote through the mail by submitting a completed ***City of Whittier Absentee By-Mail Ballot Application*** to the City Clerk's Office no later than **Tuesday, September 26, 2017.**
- Download an Absentee By-Mail Ballot Application on our website at [www.whittieralaska.gov/public\\_notices.html](http://www.whittieralaska.gov/public_notices.html) or pick up one at the City of Whittier Clerk's Office.
- Carefully complete all sections of the application and sign; omissions or errors will cause a delay in ballot mailing.
- Apply early and within the deadline.

### **APPLICATION DEADLINE**

- The application deadline for the October 3, 2017, general election is **Tuesday, September 26, 2017.**

### **BALLOT RECEIPT AND RETURN**

- Approximately 15 days before Election Day, an official ballot and voting material will be sent, by first class mail, to the applicant at the ballot mailing address listed on the application.
- When you receive the ballot, carefully follow the instructions, and return the ballot as directed.
- In order to qualify for counting, the ballot return envelope **must be postmarked by Election Day** and received in the Whittier City Clerk's Office no later than the first Friday, following the election.
- If you choose to hand-deliver the voted ballot, you must deliver it to city of Whittier election official by 8 p.m. on Election Day.

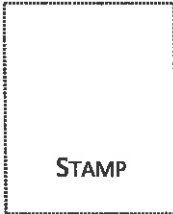
